<b>Plan Description</b>	You have chosen a Fixed Price plan. The price will be fixed for the first 12 monthly billing cycles (the "Initial Term"). You have also chosen the Green/Renewable Energy Supply Option.
<b>Supply Price</b>	The price for the electricity supplied during the Initial Term will be <input type="text"/> per kWh.
<b>Contract Start Date</b>	Your electricity supply service with Residents Energy will begin when your utility processes your enrollment.
<b>Contract Term/Length</b>	The Initial Term of the Agreement will be 12 monthly billing cycles. The Agreement may renew thereafter as described below.
<b>Cancellation/Early Termination Fees</b>	If you terminate the Agreement during the Initial Term, or if Residents Energy terminates the Agreement due to your breach, you shall pay Residents Energy, in addition to any other applicable charges, an early termination fee equal to: \$10.00 for each billing cycle, or portion thereof, remaining until the end of the Initial Term (or the then current Fixed Price Renewal Term).
<b>Renewal Terms</b>	Residents Energy will provide Customer with written notice of the pending renewal of the Agreement ("Renewal Notice") at least 45 days prior to the end of the Initial Term. The Renewal Notice will set forth whether the Agreement will renew for another fixed term ("Renewal Term") with a new Fixed Price, or will instead continue on a month-to-month basis with a Variable Price. The Renewal Notice will also set forth any changes that will apply to the material terms and conditions of the Agreement after the Initial Term. The Agreement will then automatically renew as described in the Renewal Notice unless Customer terminates the Agreement prior to such renewal. If the Agreement is renewed for a Fixed Price Renewal Term, the renewal process described in this paragraph may be used to implement subsequent renewals of the Agreement.
<b>Rescission Period</b>	Three business days from the start of the rescission period. The rescission period will begin on one of the following dates, as applicable: (i) when you sign the Agreement; (ii) when you transmit electronic acceptance of the Agreement to Residents Energy electronically; or (iii) when you receive the Agreement and Contract Summary, if received by mail.
